Out with the Old – In with the New!

that saying? Probably quite a few, and you can be sure you will start hearing it again during the next month as we close down 2019 and gear up for 2020!

Your Chamber, the CDCC, has been busy creating new programs and events to roll out for you in 2020, many of which you will find Of course, we in this publication. still have our traditional and staple events and programs that we will continue to operate and improve as the months and years go by. However, we may have a few surprises for you in 2020 which won't be mentioned in this issue of the Chamber Connections, but stay tuned – they are coming your way!

Speaking of coming our way, we have a new legislative session that will be coming our way starting in January 2020. We expect during this session, which will run from January 14th to June 30th, to see discussions around minimum wage, health care costs, a new lodging tax focused on AirBnB's and VRBO type accommodations, workforce development and training, and making our State ready for business with the "Ready in 6" initiative.

We are excited to have two new bills presented as part of the legislative discussion: HB136 this Bill proposes to end the last legislative day of the session at 7 p.m., and HB135 which proposes that any measure heading to the House or Senate from the other Chamber must arrive on or before June 20th, 10 days before the end This Bill creates what of session. will become knowns as a Delaware Both Bills are be-Crossover Day. ing proposed to allow for thoughtful deliberation and input from those with a stake in the outcome. Both of the proposed Bills would lend to more transparency in our governmental process.

Due to the way Delaware conducts its budget process, none of the three money bills (the state operating budget, capital budget and Grant-in-Aid) would be subject to these two proposals. HB26 would propose a constitutional amendment that would require a delay of 48 hours between the introduction and a vote on the three major appropriation bills.

As a Chamber, we support these proposals because they allow those who could be affected the time needed to review the proposed documents and to have discussions with their respective legislators in order to voice their concerns or support. These proposed Bills create more transparency into our government and allow for conversations and collaboration between our legislators and their constituents.

At the end of the day that is all we can ask – the right to speak, voice our concerns and support and provide our legislators with the true ability to represent the people they swore to represent!



Post Acute Medical: A Bridge to Home

"After a relatively brief stay at our facility, working with our medical team, 95% of our patients can return to their homes," commented CEO, Ted Werner. "Getting patients back to their families where they are comfortable, where they are loved, and where they will really recover is what's important. Being able to reunite patients with their families is why I come to work every day."

While Post Acute Rehabilitation Medical Hospital (PAM) may be new to Dover, it is not a new idea. There are, in fact, 43 PAM hospitals in 12 states across the country. PAM is not merely a rehabilitation center and it is not skilled nursing care. Their goal is to return each patient to his or her highest possible functional status.

Patients admitted to PAM are typically dealing with situations like amputation, brain injury, cardiopulmonary conditions, lymphedema, neurological disorders, orthopedic conditions, Parkinson's disease, respiratory failure, spinal cord injury, stroke, wounds and more. In addition to an exemplary staff of medical professionals, PAM also boasts some of the latest technology available. On the first floor, the outpatient therapy gym is equipped with the KoreBalance System. This piece of equipment measures balance and helps to inform a patient's plan of treatment. The inpatient gym on the second floor of the facility boasts the Bionik Arm which provides a way for patients who are working to retrain their muscles to refine their movements through observation and repetition. Both pieces of equipment are groundbreaking in expediting a patient's recovery.

"Opening a brand-new rehabilitation hospital" was on Ted Werner's bucket list. Ted is an experienced Chief Executive Officer with a proven history of working in the health care industry. Mr. Werner's areas of expertise include: Healthcare Marketing, Hospital Operations, Conflict Resolution, HR Policies, and Labor Relations and Business Development. Ted received his B.A. in Human Resources Management from DeSales University and his Master's Degree in Health Care Administration and Policy from Penn State University. "I love this industry. I work with amazing health care professionals. I am not a doctor, but I am the person who can connect people with the doctors they need in order to live full and happy lives at home.'

PAM is continuously operating near capacity, which demonstrates the great need for this kind of care in our community. Prior to opening, PAM's leaders spent a great deal of time getting to know the community. Part of PAM's success is attributed to the fact that they made a great effort to establish relationships in the area before their doors ever opened.

In the early days of Mr. Werner's work life, he was an intern for the Federal Aviation Administration, working as an air traffic control-

ler, guiding and directing airplanes on and off the runways. Today, with as much care and precision as he exercised at the airport, and in a hospital where patients are admitted and discharged daily, he works as a "patient traffic controller," connecting people to the services they need and then sending them back out. In both cases, his goal has been to get them safely back to their daily living... and that's what he does day in and day out.



Central Delaware: The Ideal Location

Linda Parkowski, Executive Director of the Kent Economic Partnership, Inc. (KEP), is excited about what's happening here in Central Delaware. Linda's role at the KEP is to help businesses understand why our community is the perfect place to do business. In short, she is engaged in an aggressive game of pitch and catch. She initiates conversations with business leaders outside our area, "pitches" to them all the reasons why Kent County is the perfect place to do business, and helps them to "catch" the vision of why they need to choose Central Dela-

"We are finally beginning to see some movement, some interest in our area... and people are really starting to work together!" commented Parkowski. She credits several strategies with beginning this momentum forward. Rebranding the KEP to trade as "Choose Central Delaware" has played a big role in kindling interest. "The new website has helped a great deal! It's smart – it tells them what to do ("choose") and it tells them where to go ("Central Delaware"). How much more direct can you get?"

Linda has also discovered that it takes going outside of Kent County in order to drive business here. To that end, she attended nine trade shows last year and spent a rather large amount of time sharing the good news about what's happening in Central Delaware. Her efforts have indeed interested a number of businesses and the calls are starting to roll in. Linda is currently tracking ten viable "projects," all of those are in Kent County. While she is not at liberty quite yet to disclose company names or business specs, she did share that a majority of them are small manufacturing businesses.

There continues to be conversation around the Central Delaware Aviation Complex (CDAC), a project with a thirty-year history. Experts in the industry have been employed to complete a study and make recommendation guiding potential use of this facility. The results and recommendations are expected very soon. While the usage of the CDAC may not be as wide and varied as first anticipated, Parkowski feels that it will certainly be useful and will fill a necessary role in bringing business to our county.

The Rockport Study, completed in 2018, has guided and directed Ms. Parkowski's work. One area potential area of development suggested by the study was logistics, distribution, and manufacturing. Linda spent a year creating contacts and getting the ball rolling in that industry – and the benefits of that work are beginning to be seen.

This next year, she is moving on to health care. She is working on projects in both Smyrna and Milford. These projects are designed to address the great need for additional people to join the skilled nursing workforce. Both projects include a large component for training and educating much-needed professional health care personnel.

Collaboration will be key in Kent County's economic development. Linda is working hard to include as many people as possible at the table. She is meeting regularly with area town managers. She is sharing the findings of the Greater Kent Committee's Quality of Life committee, which indicated that family entertainment outlets are a deficit in the area. Hopefully, working together, we will be able to attract businesses that will fulfil that need.

According to Ms. Parkowski, the number one issue in convincing businesses to come to our region is talent attraction. There is a great

need to develop our workforce, not just to meet the needs of today, but to address our prospective needs five and ten years from now. This need has given new birth to an initiative called "Excellence in Education," an effort to establish a partnership between education and economic development. The Greater Kent Committee, Kent Economic Partnership, and the Delaware State news came together in mid-November to launch the program amid an audience of community leaders, businesses, and educators. Other entities, like the Central Delaware Chamber of Commerce, are also making contributions towards workforce development with new programs and projects that will help emerging employees gain all the skills they need in order to become valued workers.

There is great potential in Kent County and there are many reasons for companies to continue to choose Delaware as their desired place of business. As we continue to work together on these strategies and many others including master planning, preplanning for site selections, strengthening the infrastructure, and more, Central Delaware's community of small businesses could expand and become a prime business location in the mid-Atlantic. Currently, residents and business owners of Central Delaware boast about their close proximity to three major cities - Philadelphia, Baltimore, and Washington, D.C. Perhaps in the years to come, residents and business leaders of those major urban areas will be heard, instead, boasting about their proximity to Central Delaware!

A Local Landmark Says "Good-Bye"

In 1993, "Jurassic Park" and 'Sleepless in Seattle" were showing on the silver screen - tickets were \$4.14, the "Got Milk?" ad campaign was born, kids were playing with Cabbage Patch Dolls, Beverly Hills 90210 was becoming a hit TV show... and in April, an iconic barbecue restaurant specializing in hickory smoked pulled pig (pork) was born. Owned and operated by a local Air Force family, Where Pigs Fly featured a full barbecue menu for dine-in or carry out, along with catering for any occasion.

The landmark restaurant's pigthemed, down-on-the-farm décor with their fireplace, the red and white checked tablecloths and drinks served in Mason jars always conveyed a message of warmth and welcome to local patrons and tourists alike. In addition to the pulled pork, pulled chicken, and ribs, their varied menu offered appetizer favorites from homemade onion loaf to pickle fries, and delectable sides including potato salad and, of course, their ever-popular broccoli salad. The restaurant also became known for its pig-centric gift shop that boasted unique items and conversation starters for all ages!

Kelly, who was previously employed by Shakey's Pizza, a former tenant of the building, became a business owner over thirty years ago. She continued the well-known pizza business for about 5 years before she decided to launch something completely new in the same building. 

New shops and boutiques... local restaurants... tours that bring a rich history to life... events that draw people into the central shopping district... a re-enlightenment of arts and culture... support from organized agencies... a heartfelt desire to live a "main street experience"... these are the marks of re-vitalization – and they are all happening in Dover's Downtown. A great effort has been made over the last several years to bring new life to the Downtown and the results are becoming noticeable. There's drive and persistence among the downtown merchants – and they're beginning to gain momentum.

"Everybody's on board... it's finally all lining up!" commented Todd Stonesifer, Dover native and owner of The Moving Experience. "Many years ago, my mother brought me downtown. Loockerman Street was the mall. It's where we did all our shopping!" Todd has been part of this effort since it began with the inception of Destination Downtown Dover (D3). "At first, we took our dream to Legislative Hall – we actively made our voices known... Eventually, we realized that it wasn't up to the legislators – it was up to us to make the differences we'd dreamed of.'

And with that, a grass roots effort was born to make Downtown Dover a real destination, not just a place to pass through. The City of Dover has lent a great deal of support to this project, along with many other organized groups such as the Downtown Dover Partnership, the Greater Kent Committee, and the Central Delaware Chamber of Commerce. Grants and incentives have been

offered to people who want to start new businesses downtown, and assistance in knowing how to proceed has become available.

"This city has good bones," remarked Kristin Stonesifer, owner and operator of The House of Coffi. "The structure is in place, the layout is great, and there's a certain charm about our downtown. Everything's in place!"

"Opening a boutique in Downtown Dover is like a dream come true!" Lori Llewellyn, owner of My Roots, is thrilled to have the opportunity to do business on "the main street in the capital city of the first state." "This is the heart of Delaware!" The feel of the city, its character and charm, create an inviting and interesting vibe that she believes keeps people coming back.

Anita Bezy is excited about the new development that is happening in the city. New buildings are being planned, as well as more parking and parks. Anita and her husband, Ludovic, are excited about their business, La Baguette Bakery and Catering. They love bringing a taste of France to the town, baking their goods daily on site and using only the finest ingredients, and are always looking for ways to partner with other merchants to bring the finest shopping experience to everyone! "The City of Dover and the Mayor, in particular, are beyond supportive of the downtown businesses. There's a great spirit among the merchants."

Owner and operator of Bel Boutique and The Loocke, Erin Thwaites, is a native of Dover who always dreamed of opening

a boutique in Downtown Dover. She describes a visit to the downtown area as "an experience." She believes that the downtown merchants strive to provide exemplary customer service which leads to personal relationships. "People love that! They want us to know them." Erin also feels that the rich history of the area contributes to the downtown's success. "The history here speaks to its charm."

The merchants are all singing the same song about the strength of "community." It has been said that community is an experience where people are known, served, loved, and celebrated – and that's what Dover is becoming. Kristin Stonesifer described the relationships among all the downtown entities as a "community one-ness."

"Relationships are everything," commented Ms. Thwaites. "Community is so much more important than competition!" word comes to her store that new shops and boutiques are opening across the street, she gets excited. Erin knows that more businesses will bring more people downtown and will give them a richer experience. The City of Dover, the banks, and the other organizations are making it possible to create a Main Street of specialty shops and boutiques. "I am so proud of Downtown Dover!" Erin remarked.

The re-vitalization of Downtown Dover is a process and one that will continue to be worked on and tweaked for many years to come. The downtown merchants tend to agree on the areas that still need attention and improvement. Of course, all the merchants would love to see an increase in foot traffic and the development of new businesses.

They have isolated three main issues that currently hinder this kind of growth – crime, parking, and the condition of the buildings.

The historical nature of Dover's downtown area gives it a tremendous amount of charm. And, while the buildings are very well maintained, they are old. Codes and regulations have changed over the years and have become more stringent in order to ensure safety. The costs to bring the buildings up to code and into compliance is often cost-prohibitive for prospective buyers. Some grants and incentives have been put into place to help combat this issue, but more needs to happen to ease the burden for people who are anxious to do business here.

Crimes do happen in the downtown area. As Ms. Thwaites put it, "Dover is a melting pot. We welcome everyone here. Unfortunately, some of the 'everyones' don't behave well." The Dover City Police Department is working hard to maintain safety in the city. The merchants, in general, feel that it is safe to walk around, shop, and sightsee

downtown. "People need to use common sense – and they need to understand that the things that happen downtown in the way of crime are more of a nuisance than anything."

Anita Bezy observed, "Most of the bad stories you hear about the downtown are highly exaggerated or are completely inaccurate." She maintains that the City of Dover will go to great lengths to help support initiatives designed to enhance safety, like added patrols, lighting, etc. "People must communicate through proper channels," she said. "They need to spend their energy complaining to the people who can actually do something."

Many have expressed that finding adequate, well-lit parking is a problem in the shopping district. The merchants disagree and call that observation a misperception or a myth. There is free street parking as well as metered parking lots. "People may not always be able to park directly in front of the place they're going - but they need to not be afraid to go around the corner," remarked Mr. Stonesifer. "In general, the walk from a car parked around the corner from a downtown shop will be shorter than a walk from the mall parking lot into any store.'

Downtown Dover is on the brink of something big – the changes are positive, but the word on the street doesn't always communicate that positive message. There are misperceptions about much of what people see – and

perception is everything. When asked what the general public could do to help, each merchant spoke about being involved, attending events, and shopping downtown. But more important than all of that, they would ask us to see the positive things, experience what's good, look for the uniqueness of the community - and spread that good news in as many places as possible to as many audiences as we can. Good news, positive talk, and ringing endorsements from the residents of Central Delaware are what will make the definitive difference in the revitalization of our beloved Downtown.

According to our local downtown merchants, Dover is on the move. Life is coming back into the city and the Downtown is beginning to create an amazing, unique identity that people want to be part of. "Downtown Dover is a cool place to come," mused Lori Llewellyn.

They say everything that anyone could want or need can be found downtown. "From meals to tours to culture and art to experiences, everything is available - right in your own back yard," commented Stonesifer. Much of this is due to the tenacity and determination of this group of young entrepreneurs who have invested not only money, but talent, time, and passion into the effort. For those of us who enjoy a "main street" area that we can be proud of, we owe them a debt of gratitude and our support.



Patriotic Sacrifice is a Family Affair


Veterans young and old, family members, and friends gathered at the Air Mobility Command Museum on Monday, November 11th, to commemorate Veterans Day. Nancy is also an active member of the First State Master Networks Group. Nancy and Ron have found that "networking" is a big key to business success.



A Legacy of Fine Jewelry

"I spend every day surrounded by the most beautiful things that God ever created." That's how Bev Knight describes her life as a purveyor of fine jewelry. "Look at this diamond, for example," she said pointing to the ring on her finger. "It's been worn day in and day out for many, many years and it doesn't have a scratch on it. That's real beauty." The daughter of a Pennsylvania watchmaker and jeweler, jewelry has been an integral part of Bev's life since childhood. Dealing in jewels and gems has always been a deeply spiritual exercise for Bev and something profoundly personal – a lesson instilled in her by her dad.

Duane Ernest 'Duke" to his friends, was super creative and good with his hands. He built a cannon when he was a teenager. He just wanted to see if he could. And the canon actually shot cannonballs! He carved intricate creations out of balsa wood. He wrote poetry, sometimes in a circle. He was a natural when it came to building and repairing watches - he was a master technician. A highly religious Episcopalian altar and choir boy, he knew there was more to the watch and iewelry industry than the mechanics – he was in the people business and the people are what stole his

in 1986 – and brought the jewelry business with her. Knight's Fine Jewelry first opened in the Rodney Village Shopping Center. The business was relocated in 1992 in Camden and, in 2008, finally came to its current Camden location. The building that houses Knight's Fine Jewelry tells quite a tale of local history. It was known as the Oddfellow's House and was built in 1856. It has been designated as part of the National Underground Railroad Network and is believed to have been a stop on the famous

escape route for slaves led by Harriet Tubman. The building's kitchen features a trap door that may have been used to gather slaves into a section of the basement where they hid.

Thirty-four years have passed since Knight's moved to Delaware. Bev looks back on those years with a full heart. It's been about jewelry and sales and watches and repairs – and so much more. Bev's business has been about relationships – now 2nd and 3rd generation relationships. w It's been

about creating pieces of jewelry from the ideas in her heart and her imagination. It's been about finding ways to reuse and repurpose family jewels and sentimental pieces. It's been about watching people's faces light up when the velvet box is opened. It's been about becoming part of people's families by creating items that will tell their stories from generation to generation. Knight's Fine Jewelry, under the leadership of Bev Knight, has been about carrying on the legacy of a wonderful watchmaker and father.

As the call of the grandchildren beckons and the RV awaits happy traveling inhabitants, Beverly Knight and her store will begin a new chapter. For the next several months, ownership of the store will be transferred over to her children and their families. Bev is happy to be able to stay on until sometime next summer to assist with the transition. While handing over the reins is a bittersweet moment for Bev, she is happy that the shop will stay open and the business will remain in the family. Bev considers it a blessing to know that the jewelry they fashioned and the relationships they've built over the years will continue to enrich this long-forged legacy, begun by her father, for years to come. Duke would be proud!
