Chesapeake Utilities Corporation is an Anchor Partner of the Mid-Atlantic Clean Hydrogen Hub

Chesapeake Utilities continues to advance the lower-carbon economy transition as an industry anchor partner with the Mid-Atlantic Clean Hydrogen Hub (MACH2TM). The Department of Energy (DOE) announced last October that the MACH2TM was one of seven regional hydrogen hubs selected to receive an allocated share of the \$7 billion in Bipartisan Infrastructure Law funding to accelerate the market for hydrogen in the United States. The Company's history and strong performance prove that solid corporate citizenship and environmental responsibility work together as fundamentals of good business.

MACH2TM, which is a collaborative effort comprised of industrial, governmental and educational institutions representing Delaware, southern New Jersey and southeastern Pennsylvania, was selected to receive up to \$750 million in funding from the DOE's Office of Clean Energy Demonstrations. Approximately \$250 million of the funds have been allocated to Delaware. The hub's focus will encompass the hydrogen value stream from production to end use through four main areas: training, infrastructure, reducing emissions and job creation.

"We are honored to be an active member of the MACH2TM partnership, which will channel substantial resources into our region for advancing hydrogen projects. Being an active and engaged partner in MACH2TM underscores our unwavering dedication to the local communities and customers that we serve, as we actively work to advance affordable and realistic environmentally responsible solutions that further reduce carbon emissions," said Shane Breakie, vice president, sustainability and organic growth, Chesapeake Utilities.

On Dec. 18, MACH2TM hosted an event with over 300 attendees including state senators and rep-

resentatives, as well as Governor John Carney and U.S. Dept of **Energy Department Secretary** David Turk. At the event, Breakie joined other MACH2TM partners in a panel presentation entitled, "Clean Hydrogen for the Mid-Atlantic: What MACH2TM Means for Delaware." The presentation provided an overview of the hub and detailed the economic opportunities and community benefits that it brings to the region.

Chesapeake Utilities' role within MACH2TM touches all four areas of investment and growth. As a hydrogen innovator, Chesapeake Utilities has proposed to potentially produce hydrogen and deliver it to the transportation sector, further advancing the Company's commitment to continuing to help our customers to reduce emissions by providing lower-carbon alternative fuel options, such as compressed natural gas/renewable natural gas, propane autogas and now hydrogen. With its Safety Town facility in Dover, the Company will provide regional safety training, workforce development and community engagement for hydrogen utilization.

"Chesapeake Utilities is an essential partner of the Mid-Atlantic Clean Hydrogen Hub," said Collin O'Mara, board chair of the MACH2TM. "We look forward to working collaboratively with our partners on projects to produce and deploy green hydrogen that will advance both our environmental and economic goals and further position our region as a national leader in the clean energy economy."



MACH2TM plans to unlock hydrogen-driven decarbonization in the Mid-Atlantic while repurposing historic oil infrastructure and using existing rights-of-way. Current plans include developing renewable hydrogen production facilities from renewable and nuclear electricity using both established and innovative electrolyzer technologies, reducing costs and driving further technology adoption. This hydrogen hub anticipates creating 20,800 direct jobs — 14,400 in construction jobs and 6,400 permanent jobs. For more information, visit https://mach-2.com/.

The abundance of existing infrastructure and ready access to feedstock resources in the Mid-Atlantic region will reduce overall hydrogen delivery costs, giving MACH2TM a clear advantage and an opportunity to further attract investments in new demand segments and hub regions. Furthermore, given the high concentration of hard-to-decarbonize industries within the region, MACH2TM envisions growth potential for hydrogen, both in supply and demand.



LCD Leaders Take on Laws & Legislation

On a crisp February morning in Downtown Dover, the heart of Delaware's political arena, the members of the Leadership Central Delaware (LCD) Class of 2024 embarked on a journey of civic engagement and enlightenment. Hosted by the Central Delaware Chamber of Commerce (CDCC), Government & Politics Day offered the 28 participants a unique opportunity to delve into the inner workings of the legislative process at both the state and local levels.

The day kicked off at Legislative Hall, home of Delaware's General Assembly, home of the Senate, and House of Representatives, with a continental breakfast prepared by La Baguette Bakery and Catering. As the participants entered the hallowed halls, they were greeted by the buzz of democracy in action. They had the opportunity to witness lawmakers in deliberation, gain firsthand insight into the intricacies of policymaking and governance. Engaging discussions with state legislators provided valuable perspectives on the challenges and opportunities facing Delawareans and their businesses right now.

At Legislative Hall, the first guest speakers of the day were Rep. Danny Short (39th district) and

Scott Kidner, a Contract
Lobbyist with C.S. Kidner and Associates, who dug deeper into how a bill becomes a law during session on the floor below where they were sitting. They highlighted the

importance

of knowing the senators and representatives of one's district, how they value the community's input, and how their influence and role impacts the state legislature. They discussed current bills like the recent Permit to Purchase Bill, as well as legislative advantages specific to Delaware.

Three degrees of separation is how the connection of Delaware's population is described, which is especially true for other industries of Delaware. A common theme from both Short & Kidner was communication and relationships as keys to government affairs in the First State. They emphasized the impact relationships have made on their careers and how they've translated far outside the walls of Legislative Hall. They illuminated that, contrary to public belief, government affairs and legislative processes can move very fast, especially on the House floor. It is not unusual for a person to only have 2 minutes to respectively explain their viewpoint in the hopes of bringing their perspective to the conversation.

Next, the LCD Class took a guided tour of Legislative Hall led by Steve from First State Heritage Park. Legislative Hall is majestic on the inside as its exterior is currently under renovation. When you enter the building, the House chamber is in one wing and the Senate chamber is in the opposite wing. The building's two floors are connected by a center staircase. The first floor gives access to the chambers and offices while the second floor gives access to the balconies overlooking the chambers, as well as more offices. The class viewed portraits of famous Delawareans, as well as important moments

> in Delaware history painted by a local Delaware teacher.

The LCD Class then returned the House Hearing Room for a lively round table discussion of the most recent hot topic from the Delaware Department of Natural Resources and Environmental

Control (DNREC), the Advanced Clean Car II program, commonly referred to as the Electric Vehicle Mandate. The discussion, led by Representative Jeffrey Spiegelman (District 11), shared the facts, concerns, timelines, and his personal interpretation of the State mandating that all new cars sold in the state be electric by 2035 in order to cut air pollution. The class was left with much to analyze about this new mandate that will dispro-



portionately affect poor and working classes. Breaking into small groups, they each discussed and presented their thoughts on the issue and its impact on Delaware.

The Class broke for lunch catered by Capriotti's Sandwich Shop of Dover and mingled with a few legislators who took time out of their busy day to stop in and share a warm, personal welcome. The room resettled and the group turned their attention to Kelly Pitts, Kent County Levy Court Public Information Officer, fellow LCD Class of 2022 alum. She shared a brief glimpse of the role of local county government covering 586 square miles and 186,000+ population of Kent County. This was important for the class to grasp because the responsibility and jurisdiction of Kent County Levy Court can often be misunderstood. Her presentation and handout gave clarity to the class regarding federal and county legislative affairs that help our city and community run overall.

Later in the afternoon, the group welcomed Brian Stetina, Director of

Operations at Faw Casson, and past CDCC Board Chair, and Janie Libby, retired Human Resources representative at Dover Downs, to delve into the Family Medical Leave Act. They both shared the background implications this approved act will have on small business owners. Libby and Stetina worked closely with the CDCC and legislators all throughout the process of this bill becoming law. They influenced changes that may have otherwise been overlooked and which ultimately helped the bill be more small business inclusive. Through this discussion, the class was able to gain new insights and perspectives about what happens behind the scenes when it comes to local business legislation.

Speaking of the CDCC and legislative affairs, Dina Vendetti, CDCC President and Judy Diogo, past president, shared the floor to give the class the inside scoop of the CDCC's role in Legislation. Vendetti shared the CDCC's role in legislation and the process of affecting a bill for the better before it is officially passed. The CDCC has two lobbyists to represent and protect the needs



of small businesses. Members are encouraged to share their concerns with the CDCC about legislation that will affect them and the CDCC will work on their behalf. This is a very important resource for not only CDCC members, but the community as a whole.

To round out the day, the class took a quick walk over the City Hall to meet with none other than Mayor Robin Christiansen in the Council Chambers. The class roleplayed the hypo.thetical annexation of Schimp Farms with grace and stifled laugher as they really stepped into their characters to act out a Mock City Council hearing. Although hypothetical, the issue at hand was very similar to a real-life example of issues the City Council faces, debates, and finally decides upon. It was entertaining to watch but just as informational. The CDCC commends the LCD class of 2024 for successfully doing their homework and immersing themselves in the process.

Government and Politics Day for the LCD Class of 2024 was a success! They class asked great questions, shared ideas, and forged connections with figures in legislative affairs. They gained a deeper appreciation for the complexities of public service and the importance of civic engagement in fostering positive change. The experience left a lasting impression, inspiring the future leaders of Central Delaware to actively contribute to the betterment of their communities. The strongest theme of the day for the Class of 2024 is an important theme for all of us: Your Voice Matters!



Leadership Deep Dive: "It's Your Ship"

The Leadership Central Delaware Class of 2024 is in full swing and more than halfway through their 10-month program together! A requirement of the program is to collectively read: "It's Your Ship: Management Techniques from the Best Damn Ship in the Navy," a leadership book written by Captain D. Michael Abrashoff, a former Navy commander who took command

of the USS Benfold, one of the worst-performing ships in the U.S. Navy's Pacific Fleet. The book outlines Abrashoff's leadership principles and how he transformed the Benfold into one of the best ships in the Navy.

This is a such a fitting story for this group of 28 leaders because the key themes tie directly to leader-

ship, empowerment, teamwork, and fostering a positive work culture. Abrashoff upholds the action of top-down change that can be applicable to business and work-related teams. "The best ship in any fleet is the one whose crew works together as a team," Abrashoff wrote. He emphasizes the importance of giving control to the people doing the work, trusting them to make decisions, and holding them accountable for the results. He believes that by giving his crew ownership of their jobs and fostering a culture of trust and accountability, they were able to achieve extraordinary results. "If you take care of your people, they will take care of the mission," he continued.

During each meeting, classmates are appointed to take turns leading the discussion on the two chapters assigned. This encourages classmates to share in constructive dialogue to incorporate their personal takeaways and perspectives. Undoubtedly, there is something very unifying about reading a book together in the likes of a book club and the LCD Class of 2024 is doing it with ease!



In addition to meeting all requirements in the nine sections of the regular accreditation process, this Chamber has been given special recognition for several programs and services that impact its community in a profoundly positive way.

The CDCC was commended for its comprehensive process to develop its annual public policy agenda and was recognized for fostering an excellent working relationship with elected officials through frequent trips to meet lawmakers at the General Assembly to discuss priority issues for the

The robust Communications and Marketing Plan of the CDCC which includes a variety of channels and tactics to reach its members like broadcast emails, the widely read Chamber Connections newspaper highlighting member news, two Facebook Live broadcasts each week, and more was commended, along with the CDCC's excellent relationship with the Daily State News. The Chamber's Technology Committee, which has worked tirelessly to make several improvements that assist members, increase staff efficiency, and streamline processes was lifted up in the final report.

Internally, the CDCC was noted for its comprehensive Leadership Guide and Committee Handbook used to train and guide members of its Board of Directors, and its Board Orientation program. The way that the CDCC recognizes volunteers was seen as excellent, as was its Employee Evaluation process. And finally, the Chamber's member retention efforts, including its 5-Star Journey Map to Engagement, were deemed noteworthy.

According to this group of independent, unbiased evaluators from the U. S. Chamber's Accreditation Commission, who have visited and studied

These are items that not only assist members in growing their businesses, but also pack a powerful punch when it comes to business-life here in Central Delaware.

KSI Welcomes New CEO, Heath Chasanov

Their mission to empower individuals, enhance their quality of life, and promote their inclusion in the community has been the driving force behind everything their staff does. Kent Sussex Industries, Inc. (KSI) has long been a beacon of hope and opportunity for individuals with disabilities. To carry the torch today, KSI and the community welcomes Heath Chasanov, newly appointed Chief Executive Officer (CEO).

With a wealth of experience and a passion for empowering the next generation, Chasanov is equipped to lead KSI into a strong era of growth and innovation. With a few months settled into his new position, he is delighted in finding the crossovers and similarities reflected from his 32 years in education and the services and responsibilities needed at KSI. "My first two months home really been about trying to figure out the key people here internally at KSI and what they do, and then who are our key external partners and where are the opportunities to expand," shared Chasanov.

Overseeing the strategic direction of an organization and implementing changes and plans, monitoring company performance, and engaging in media relations are just some of the universally acknowledged responsibilities of a CEO. Allocating capital is a very important responsibility as well. "I'm the kind of person that likes to understand the money. I like to understand the revenue behind an organization. And so, I spent a lot of time with that," Chasanov stated in preparation for this position. "Just trying to understand the funding structure, you can learn a lot about the parts of an organization by looking at their budget and where they're putting their money."

Heath has served as an Administrative Assistant, Admissions/ Federal Programs Director, and

Business Education teacher for Polytech School District. Some of the titles contributing to Chasanov's experience of serving students include Business Manager for the Laurel School District, Woodbridge School District Superintendent, President of the Delaware Association of State Personnel Directors, the Delaware Chief School Officers Association, and the Delaware Association of School Administrators. "I think leadership is leadership. No matter what field you're in. I think you build relationships, and you treat people with respect."

Although KSI is a smaller organization in comparison to a school district, the fundamentals of leadership are the same in Chasanov's eyes. "It's a matter of just making sure folks understand, what is the shared vision," reflects Chasanov on transferring his servant leadership style to KSI.

"I really do believe that I've always been that way; that my job as a superintendent was to try to take away as many barriers as possible to make our teachers, who are the most important part of our system, focus on their classrooms. So, it's the same here as you find out where the resources are, what our folks need, and then get out of the way and let them do their jobs. I don't have to have all the answers. I have to be smart enough to know who has them."

After 32 years in education, Chasanov knew he wasn't going for 42; he was ready for a new challenge and kept his ears open for the past year or two. Being affiliated and familiar with KSI's initiative throughout the years, he admired that the people who work at KSI are here because they want to make their participants lives better, and they do. "I wanted to do something else. But I wanted it to be meaningful," he stated.

KSI's facility, staff, and programs cover a variety of needs for their participants. To some, KSI is a place to go to enjoy life, have an art class, or work on computers. To some it is a place to develop valuable vocational skills that lead to greater inde-



pendence and employment. KSI is very similar to how schools run their special needs departments. At KSI, it comes down to the individual's unique needs.

"That's the beauty of an organization like KSI - to bring a group of individuals together with similar needs and be able to leverage that and go to a company and go, 'hey, here's what we can do for you. We've got a workforce here that can do these things for you, potentially at a lesser cost, but also, look at the purpose that you're fulfilling for these folks.' To watch our participants get their paychecks is a pretty special thing," Chasanov reflected.

Getting his feet under him as new CEO, Chasanov has one foot in the present operations and another in the future as they undergo strategic planning sessions for the next couple of years. Ideals of getting back to pre-pandemic results are of importance. Top three goals on the horizon are "to get our state-of-the-art facility for our participants, increase the amount of business partnerships that we have and opportunities for our clients to continue to work, and to have the organization continue to be recognized as a leader in providing services for adults with disabilities," Chasanov disclosed. Of course, funding is always a challenge to overcome, and he anticipates this still being true.

With challenges come opportunities and Heath is excited to delve into those as well. He is looking forward to having conversations with local businesses that hopefully lead to additional programs like the ones they have with Proctor & Gamble. "I am really excited about this opportunity and in leading this organization forward. We're an organization that's committed to our participants. We're 100 percent committed to the opportunities that present themselves in the future and that we are looking to grow," he concluded.

Professional Power-Up Addresses Corporate Transparency Act with Corp1

Have you heard of the Corporate Transparency Act (CTA)? Enacted into effect this year, this filing is critical and mandatory to the success of all small businesses – So why isn't anyone talking about it?


The Central Delaware Chamber of Commerce (CDCC) was concerned to hear of this Act that calls for all small businesses to act – and act fast. The CDCC thanks Kelly Manchester, President of Corp1, Inc., for sharing this information with us and the Professional Power-Up virtual audience this past February 13th. The CDCC knew we needed to get this in front of our members as soon as possible.

"It's our job in this industry to help get the word out to all small business owners that they have one year to file, and if they don't there are significant penalties. There is an uphill battle for FinCEN to get this notice out to all small business owners. They're discussing using commercials, public service announcements, lawyers, accountants, and registered agents like us. If small business owners are not talking to their registered agent or CPA, they're not going to know about it. Yes, most Secretaries of State have links on

their websites, but what small business owner routinely peruses that website looking for information; not many," shared Manchester.

Taken from Corp1's succinct "Corporate Transparency Act: What You Need To Know" document, the primary action of CTA is as follows:

Beginning January 1, 2024, all new entities ("reporting company") will need to file a Beneficial Ownership Information Report (BOIR) with the US Dept. of Treasury, Financial Crimes Enforcement Network (FinCEN). This BOIR must identify the beneficial owners and anyone with "substantial control" of the reporting company. They also must identify two of the "company applicants" involved in the process of forming the entity, within 90 days from the date of receiving

actual or public notice of their creation or registration becoming effective to file their annual reports.

Domestic or foreign reporting companies formed or registered before January 1, 2024, will have one year (until January 1, 2025) to file their initial reports.

Reporting

Companies have 90 days to report any changes to the information in their previously filed FinCEN reports and must correct inaccurate information in previously filed reports within 30 days of when the reporting company becomes aware or has reason to know of the inaccuracy of information in earlier reports.

So, what is the point of this Act? Good news, it's not just more busy paperwork for already occupied businesses. The CTA aims to combat money laundering, terrorism financing, and other illicit activities by requiring certain companies to report their beneficial ownership information to the Financial Crimes Enforcement Network (FinCEN).

The CTA targets shell companies, which are often used to disguise the true ownership of assets and facilitate criminal activities. These entities, while legal, have been exploited by individuals seeking to evade taxes, launder money, and finance terrorism. By requiring companies to disclose their beneficial owners, the CTA seeks to create a more transparent business environment and prevent illicit financial activities.

Protecting the interests of CDCC
Members is our top priority, but
all small businesses need to know
this information
and file as soon
as possible to
avoid hefty fines.
Companies that

requirements may face fines of up to \$500 per day of non-compliance, as well as potential criminal penalties, including fines of up to \$10,000 and imprisonment for up to two years. This is nothing to gloss over. It will be the "Mom & Pop" businesses who will really feel these effects if not filed in time.

with the reporting

This is important news for the CDCC as it is important news to you and your business. We don't share this information to scare you into compliance, but we want you, our members, to have all the necessary information to avoid legal penalties that will impede your ability to operate.

The Return of a Community Friend: Dawne Nickerson!

Back in 2021, the Central Delaware Chamber of Commerce (CDCC), friends, and community bid a bittersweet farewell to the one and only, Delaware-native, Dawne Nickerson. The community may most notably know her as the Chief of Community Engagement for 436th Airlift Wing Public Affairs at the Dover Air Force Base (DAFB) from 2016-2021 before transferring to the 628th Air Base Wing, Joint Base in Charleston, S.C. If you've known her, or even heard of her name, you could infer that this wasn't an easy goodbye to an influential and kind-hearted community figure. However, the CDCC is excited to share the news that Dawne Nickerson has returned, and Central Delaware is better for it!

Nickerson's relationship with the CDCC spans years across her career. "I felt like I never left the CDCC, they have always been just super supportive. I can't even tell you how long I've been involved with the Chamber. I attended mixers when I worked for Kent Sussex Industries, Citizens Bank, when I owned my bakery (Frankfurt Bakery), and since I've been at the DAFB," Nickerson stated.

Presently as of January 2024, Nickerson is now the Chief of Public Affairs for the Armed Forces Medical Examiner System (AFMES) located on DAFB. AFMES is a mission partner for the DAFB that provides the Department of Defense and other federal agencies comprehensive forensic investigative services. Their mission is to investigate deaths, identify the fallen, and improve readiness and survivability. As you can tell, Nickerson is no longer on the Air Force side of the mission and her duties look a bit different, although just as critical.

"I now work for the Defense Health Agency which is an Army-run agency that reports directly to the Secretary of Defense. It's very different but it's a very unique mission set, and I have two amazing Airmen that work for me. It's going to be great and, who knows, this could be my last hurrah. I'm really happy to be back home and around my family," stated Nickerson. Her new position entails communicating to the public and other stakeholders how AFMES is not only a good steward of tax dollars, but they also provide honor, dignity, and respect for the families of the fallen. She has a duty to protect the privacy of the fallen and their loved ones.

Unlike the constant push of news and information to the public in

her 436th Airlift Wing position, in contrast, her responsibilities are to support the mission of AFMES through sharing the great things their DNA lab is doing. "My focus now is on pushing out and sharing the great people that pull off these missions and the great things that they're doing every day to take themselves above and beyond the norm."

"These folks are identifying DNA of returned members even if it's from a past conflict. They're finding people from World War II, Korea, and Vietnam and they're able, through emerging technologies, to repatriate these folks. The family that never thought they were going to see their loved one ever again are now given closure and I just I love that piece of it," explained Nickerson. She further explained the breaking news of the Forensic Pathology Investigations division receiving accreditation from the National Association of Medical Examiners this past February 2024, making them the first in the Department of Defense to obtain this status.

As you can tell, AFMES plays a crucial role in supporting the military and other government agencies by providing accurate, timely, and reliable forensic services

public health, and the administration of justice. Nickerson's role in the operation is to take care of her Airmen, fostering a family work environment with thorough communication, researching policy, rules, and regulations, and providing family member updates. "In March, I'm going to a family member update with our lead doctor. That will include a family member update and a chance to collect DNA samples of any family members that still have service members missing and are willing to offer their DNA for potential matches," she explained.

that contribute to national security,

Dawne is undoubtedly a go-getter and a problem-solver who is guided by the famous motto "Just Do it." She believes in cultivating a happy workplace where everyone looks out for each other. She is inspired and by the potential impact her work has on others. "I just like having an impact and I think that's what keeps me going. Everything I've done in my career has had an impact on somebody at some point. To be able to leave that mark on that territory, piece of the world, neighborhood or that population - that's what keeps me going" she reflected.

In addition to settling into the same house she left and enjoying the familiarities and comforts of home, Nickerson is very excited to pick up where she left off by connecting her airmen to the Dover community. "I think on a human level, these people live and work in our community, their kids go to our schools. Therefore, I think it's important for the civilian community to welcome & embrace them. They have a tough enough life as it is, bouncing around from location to location. It would be my complete desire for everybody that's stationed at Dover, that works and lives in the community, to be able to say, "You know what? My favorite duty station was Dover because the people there were just incredible."

"I mean Charleston's a great place to visit. I had a great group of friends and network down there in Charleston, but it was never really my network, not the network that I had taken 50 years to develop, and it was not the friends that I have cultivated

over the last 45 years. There's a lot to be said for just being comfortable, being home, and being around the people that you love and that love you," concluded Nickerson.

Her passion for serving others and her commitment to building strong relationships between the military and the civilian community make her a valuable addition to the Central Delaware community. 
