Lunch and Learn on Governmental Relations

The Professional Power-Up Lunch and Learn keeps recharging attendees session by session! This past Tuesday, March 12th, CDCC members logged on via zoom from 12-1pm for an enlightening presentation from Heather Contant, Director of Government & Community Relations at Delaware Municipal Electric Corporation (DEMEC). Her presentation covered the value of government relations, and how citizens can get more involved.

Contant shared the steps that led her to the position she happily holds now at DEMEC. She credits much of her initial learning to her experience as a University of Delaware Political Science graduate and Legislative Aid at the start of her career. She highlighted the historical significance of legislative affairs in the heart of the First State since the 1700s. Contant explained the responsibilities of her role, describing them as "balancing advocacy efforts and the message" and "removing the jargon" from concerns of her organization so legislators can understand better. Citizenship was a major element of her platform as Miss Delaware as well.

Governmental relations not only play a crucial role in the success of businesses and organizations, but for citizens as well. This accessible level of state government in Delaware has the greatest impact on resident's quality of life. Heather Contant highlighted the importance of building relationships with elected officials and government agencies to advocate for policies that benefit the business community. She shared valuable links, resources,

and ways for citizens to get their voices heard and stay informed, both personally and professionally. She encouraged attendees to attend town hall meetings, House hearings, sign up for email alerts and committees, and follow legislators on their social media platforms.

The CDCC is grateful to have Heather Contant working hard on behalf of the community and our members and even more grateful for her sharing her time and expertise with us. She made the perfect conclusion by reading "Unless someone like you cares a whole awful lot, nothing is going to get better. It's not," a quote from the Lorax by Dr. Seuss, which hangs in her office. Whether it suits the interest of your company, organization, or personal convictions, it's best to practice your civic duty in the present, instead



of just publicly complaining after it's happened. Thank you, Heather Contant!

PAM does an excellent job of letting everyone know what is going on."

"Our goal at PAM has always been to help those in our community recover and thrive following a significant injury or illness. We are so excited to have Rob in his role as a workers compensation account executive. His knowledge and expertise in the field allows us to better meet the needs of Delaware's business owners and the injured

employees we are honored to be able to get on the road to recovery," shared Erin Del Farno, RN, & PAM Health Market Director of Strategy. "Workers Comp can be a daunting task to navigate, there are already so many stressors just from having the injury have occurred. Rob being there to bridge the gaps for us and be a liaison between the carriers, employees, and businesses allows us to better meet the needs of our community."

"This program is unique in that it allows us to go a step further from getting our patients safe to go home and allows us to help them to recover to the point that they can, ideally, get back to work. We know in the current climate how important it is to maintain our essential workforce," continued Del Farno.

In contrast to other workers compensation-related positions he's held in the past, Kroneberger appreciates getting to see the positive end results of his work on a personal patient-by-patient basis. "I never got to meet the injured worker, and now I'll get to meet them, and it's gratifying to know what I do for the job is really helpful," he continued. Kroneberger believes that PAM is exceptional at what they do to help others who need it the most. He is proud to

work alongside a team the exhibits great empathy for their patients and passion for doing their jobs.

"I had the chance to meet with one of the patients while I was in the hospital. He was a paraplegic, but we saw some physical improvements within a week for him, and when I spoke with him, it was the mental part that I thought was absolutely incredible. He said 'Rob, I have to stop thinking of myself before I had this injury. I'm now thinking of where I am now, and where I'm gonna be in the future.' I tell this story all the time, cause that's what we do. In these injuries, someone's never going to be who they used to be, as far as physically, and it's just moving, it's incredible."

Kroneberger will be working alongside the PAM team that is known for providing great support for Central Delaware's first responders. "One of my biggest honors personally through the addition of this program is that it has enabled us to care for several injured firefighters, EMTs, and police officers. We as a corporation appreciate all the things they do for our community every day. While we are saddened for their injuries, it is also a great honor to be able to care for them in their time of need as well," shared Del Farno.



"We offer a pretty complete service and I think we really do it well," concluded Kroneberger. When he is not busy supporting workers in dire need, he can be found enjoying the outdoors and staying active with his two children on the Eastern Shore.

LCD '24 Public Safety & Criminal Justice Day!

The Leadership Central Delaware Class (CDCC) of 2024 recently experienced an insightful and eye-opening day focused on Public Safety & Criminal Justice. Held on March 7th, this immersive experience was designed to provide participants with a deeper understanding of the challenges, necessary leadership qualities, and responsibilities within these critical sectors – as well as a few surprises along the way.

Data driven, goal setting, and skills of discernment were the themed leadership traits of the day which began with a panel discussion comprised of Captain Joshua Bushweller (Delaware Information and Analysis Center Director), Chief Elmer

Harris (Delaware Capital Police), and Major David Rattè (436th SFS/ CC Commander at Dover Air Force Base). The panel explored several topics, including police recruitment and retention - one of the biggest challenges facing law enforcement now. The class had great questions for the panelists that provided honest, real-time answers about their professions and leadership styles. The panelists shared how they strive to develop cultures of

accountability within their agencies, inspiring leadership, and how they make tough, life-or-death decisions when they are needed most.

After a quick break, the LCD Class of 2024 resumed with Violent Intruder Preparedness and Response (VIPR) training (Active Shooter training) from Detective Chris Nicholson (Explosive Ordnance Disposal Unit & Terrorism Liaison Officer, Delaware State


> Police). He provided an eye-opening, statistical, analysis of mass shooting and terrorist attacks in America. The case studies presented were unforgettable and stark reminders of the world we live in and the precautions we all need to take to maximize collective safety. This

training is available for everyone and should be considered in all businesses, organizations, and groups.

Stephen Burgess (LCD Class of 2021, co-Chair, Fireside Partners **Emergency Operations Center** Manager) happily served as host for the day. He introduced the class to the work of Fireside. Fireside is a crisis management consulting firm in Dover doing amazing work all over the world. The company

provides a range of crisis management services to help organizations prepare for, respond to, and recover from crisis situations. They support clients in the event of a crisis including natural disasters, terrorist attacks, and aviation incidents (the class received a tour of where this action happens). They work with a variety of clients, including businesses, governments, healthcare organizations, and educational institutions, which Burgess addressed in his presentation. Burgess stressed the importance of businesses, no matter the size, having frequently updated emergency procedures and equipment on site. Overall, Fireside Partners, Inc., plays an important role in helping organizations to

prepare for crisis situations - a true hidden gem of Central Delaware of which many people are unaware of. Next on the day's agenda was a visit to the Delaware Information & Analysis Center (DIAC) where Lt. David Hake, Deputy Director, Intelligence Center & Homeland Security, DIAC, DE State Police led a tour of the fusion center. DIAC is a center established by the Delaware State Police to enhance communication and collaboration between law enforcement agencies, the private sector, and the public. DIAC provides intelligence and analysis to assist in the prevention and response to criminal and terrorist activity. The center also serves as a hub for the sharing of information





between law enforcement agencies and the private sector. Overall, DIAC plays an important role in enhancing public safety in Delaware by providing critical analysis to support law enforcement and other public safety efforts exemplified by Lt. Hake and his team. They shared their leadership skills and qualities that help them succeed under immense pressure.

Next, the LCD Class of 2024 traveled to the Delaware State Fire School (DSFS) where Tucker Dempsey, Training Administrator, explained the purpose of the school and tips for fire prevention, and took the class on an outdoor tour of the facility. The DSFS is an organization that provides training and education to firefighters and other emergency responders within the state of Delaware. The DSFS

was established in 1921 and has since grown to become one of the leading fire training facilities in the region. DSFS plays a critical role in ensuring that firefighters and emergency responders within the state are well-trained and equipped to respond to a wide range of emergencies and disasters. Through its training programs and other services, the DSFS helps to protect the safety and well-being of the citizens of Delaware. The class had wonderful questions for Dempsey that highlighted his leadership style and extensive experience.

The day ended at Delaware State Police Academy with Captain Kerry Reinbold, who oversees and leads the incoming academy cadets in training to protect and serve as police officers. He shared a thorough presentation about how the academy, and he himself, specifically trains new cadets. He explained that there is a purpose behind every obstacle and discomfort each cadet must endure before graduating. Captain Reinbold exemplified the organization's pillars: Honor, Integrity, Courage, Loyalty, Attitude, Discipline and Service.

The CDCC wishes to thank our public service officials for taking the time out of their busy day to be with the class. We thank them for extending their hand to the community to increase transparency, connection, and knowledge. The CDCC would also like to thank Co-chairs Denise Vendrick of Faw Casson, Stephen Burgess of Fireside Partners, and Kathy Jordan, retired, for their fundamental support and assistance of Public Safety Day. The CDCC would like to extend

our thanks to Fireside Partners, Inc. for the donuts and coffee, and the Bavarian Bakery & Deli for the delicious, assorted sandwiches, salad, & pastries that fueled everyone for a bright-eyed, successful day!

The class left with a renewed understanding of what it takes to maintain a safe community. They learned a lot about the mind of first responders, their leadership qualities, and responsibilities. Most essential of all, they learned that every person has a civic responsibility to keep the public safe. As a leader, it is the responsibility of each of us to stay educated, informed, and prepared! Thank you to all Delaware public safety leaders who serve this community every day!



"We are a very diverse company in that we can do a lot of different things," stated Steve Dennis, President of the company.

Operating a family-owned business for 70 years is no easy feat, no matter the industry. Businesses must innovate to navigate the twisting road of small business. They need to have a unique "it-factor" with unwavering core values and prin-

ciples, and Schlosser is a great example of that. "We still have a live person answering the phone. We like to deal with people on a personal level. That is something that came from our past and we want to honor that into the future," continued Steve Dennis.

The family is proud to now have the third generation working for the company. Their oldest son, Zach has

recently joined his two brothers, Chris & Justin, who work as estimators for Schlosser. "My brothers and I worked out in the field at Schlosser over the summers during high school. After I graduated college, I worked at Siemens; I had a very good career there but once my son was born I began thinking about how my brothers and I were raised in the family business, it changed my whole perspective. Thinking about family, the future and what's really important," shared Zach Dennis, operations manager.

Garnet Schlosser Dennis, daughter of founder, Paul Schlosser Sr., and Vice President of the company, is excited to have 3, (potentially 4 with the addition their new baby grandson) generations of family carrying the Schlosser Way. "What we're really asking Zach to do is to continue to fix and improve all of our processes so that we can do a better job for our customers from the very beginning to end. "We're pretty good at getting work and getting work done. Those backroom processes are what seems to slow family businesses like ours down a bit," explained Steve Dennis.

How does one even begin to summarize 70 years of family business? "Where we are now was never even imagined by my dad 70 years ago. I don't know if he ever really envisioned what we've grown into. If he could see where we are today, I think he and my brother (Paul Schlosser Jr.) would be pretty proud," reflected Garnet Schlosser-Dennis. Paul Jr.'s leadership of the company (with Paul Sr. taking

on a consulting role) was marked by ongoing growth, including significant inroads into the commercial market. Upon Paul Jr.'s passing in 2013, Steve (who had joined the company in 1992 primarily focusing on the service department) became president, and the progress and dedication to the legacy continues to this day.

Like many origins of family businesses,

Schlosser & Associates was established by Paul Schlosser Sr. in 1954 as a means to provide for his family. "He was doing this by himself in the



beginning and he gradually added a few employees. Now, 70 years later, we feel like it's our responsibility to provide for the 48 families that work here, not just ours. The number of families this company now supports, may be one of the biggest changes that has evolved over the years.", says Steve.

The world and its circumstances are always changing, but values, morals, and practices of small businesses that remain and stand the test of time, are inspiring to hear. "Take care of your customers first, then take care of your associates, we call our employees associates. We encourage our associates to do the right thing for the customer first and everything else falls into place. Our core value is customer service, provide what they need at an affordable price and do honest, quality work," shared Steve Dennis. There is a lot of pride infused into this company because of the foundation of heritage, honor, legacy, and integrity.

Schlosser & Associates has conquered challenges resulting from the COVID-19 pandemic, deep loss of two family pioneers (Paul Schlosser Sr. also passed away in 2013), rapidly rising costs, and more, but the successes have made the trials worth it. "In 2019, the company was recognized with a Family-Owned Business Award from the Delaware Business Times, which was, I think, very gratifying to everyone. It's a pretty competitive process. In 2022, we were recognized with one of the Superstars in Business awards from the Delaware State Chamber of Commerce as well, which was certainly well-earned





for all the years the company's been serving communities and is something we really appreciated," highlighted, Paul DeMara, Director of Marketing Communications & Research.

The company, its family members, and associates have a lot to celebrate this year, and this extraordinary milestone is icing on the cake. The next 5-10 years will see a lot of transition of leadership and responsibility from parents Steve & Garnet to their 3 sons. "Our three boys love each other and enjoy working



The CDCC: Your 5-Star Chamber

So, What Does That Mean? (Part 3 of 3)

This article is the last in a series of three written in an effort to bring insight and understanding into the details of what accreditation really means, why it's important, and the feedback the CDCC received from the U. S. Chamber of Commerce at the end of the process.

In the first couple of articles in this series, you have hopefully gained a better understanding of the accreditation process and why your CDCC was designated as a 5-Star Accredited Chamber. It is really quite an intricate and exhaustive process, but one that ensures high quality and a good return on the investments of members. In this final article in the series, we are going to attempt to answer the question "Now What?" This article will provide insight into your Chamber's plans for the future and its designated areas for growth in the next five years.

While the 5-Star Accreditation is certainly something to celebrate in a big way, it should never be viewed as a grand finale, but rather, as a steppingstone to continued growth and improvement. In the final stages of the completion of the accreditation process, applicants are required to look ahead and name five short-term goals, that is five goals that can be completed (or can be well on their way to completion) at the time of the next accreditation, which for us would be in 2028. Since we'd recently spent a great deal of time talking about the future of the CDCC and launching a new strategic plan, goals were relatively easy to generate. We worked to capitalize on areas that would generate growth, fulfill some expressed needs of our members, and above all, ensure the Chamber's relevancy.

Our first goal is to increase our membership to encompass 12% of the businesses in Kent County. Currently, we capture about 10% of the licensed businesses in this area. This goal would require us to increase our membership by adding 90 – 100 businesses. An interesting phenomenon became clear to us as we went through the accreditation self-study: we learned that we are exceptionally good at telling the stories of our

members, but we have not been as good at telling our own story. We offer many opportunities for members to market their businesses, but we also need to become proficient and intentional about marketing the CDCC.

Our second goal is related to the first. As we add members to our mix, it is equally important to retain the members we already have. The key to member retention is engagement. As members become more engaged with us by taking advantage of their member benefits and actively involving themselves in events and activities, our retention rate will grow. We will be working diligently to add ways to encourage our members to remain engaged. Currently, our retention rate is 88% - we would like to see that grow to 92%.

The creation and implementation of a Small Business Think Tank is goal #3. There is an amazing wealth of knowledge and experience in our membership. We are entertaining the idea of creating a sort of "master mind" think tank that can be assembled to assist other business leaders as they navigate their way through challenging situations.

As we all know, effective networking is critical to the success of small businesses. Expanding one's network is done in a variety of ways by attending events, participating in activities, connecting, and collaborating, and the like. One of the characteristics of our now post-COVID world, is that people are finding it more convenient and more comfortable to use online platforms for just about any aspect of their businesses. Most of the networking events presented by the CDCC are in-person events, which we love and find valuable, but which are not always the most convenient for busy business leaders. To that end, our fourth goal is to create and implement a virtual networking program. This new online offering would not take the place of our in-person networking but would simply add another option for those who find it difficult to leave their businesses for an event.

And finally, our fifth goal is to create a new Mastery Component for graduates of Leadership Central

Delaware LCD). Some of you will remember that, in years past, we offered a Leadership Mastery class by contracting with one or more businesses that provided that kind of additional training. At this point, we believe that we could be in a position to create our own CDCC Mastery program. We would love the opportunity to pull together some of our membership's stand-out leaders to create a framework and curriculum, design a program, employ instructors, and offer a "next step" to those who complete LCD.

As you can see, there's always room for improvement and growth – and that's what will ultimately keep your CDCC relevant and essential to the health and wellness of your business. We are eager to explore these new opportunities and encourage you to stay tuned as they evolve from ideas and dreams to realities over the next five years.

To end our series, it seems most fitting to simply share with you the final words on our accreditation report from the U.S. Chamber of Commerce: "The chamber has demonstrated a good track record of operating a successful chamber and achieving desirable results for its members. The chamber should address the recommendations in this report and pursue a course of continuous improvement. The U.S. Chamber of Commerce is proud to accredit the Central Delaware Chamber of Commerce with our Five-Star designation. Congratulations on this remarkable achievement!"
